GUEST COUNT

Relative to all reservations of twenty (20) Monday – Thursday or Thirty (30) or more Friday & Saturday: If less than the original headcount attend \$10 per guest will be charged for each guest not in attendance.

TIME LIMITS

All reservations will be limited to three (3) hours unless agreed to and approved by management prior to arrival on the date and time of your original reservation. In the event the time limit exceeds three (3) hours and is agreed to and approved by management, you will be charged an additional fifty (\$50.00) Dollars per hour. When setting time limits, hours of operation will be taken into consideration. (Sundays 10am-2pm, Mondays-Thursdays 10am-9pm, Fridays & Saturdays 10am-10pm) No reservations will be taken after 7:30pm.

CHANGE AND/OR CANCELLATIONS

Any changes regarding the headcount of your original reservation must be given to **Fezzo's Seafood, Steakhouse & Oyster Bar** at least forty-eight (48) hours prior to the original reservation. Cancellations, for reservations must be made no later than 2 business days prior to the scheduled event or will be subject to a twenty-five (\$25.00) dollar cancellation fee.

ROOM CHARGE
